Since opening in June of 2003 a converted office space into the Clothes to Kids store has served over 17,000 children, a 501 © 3 non profit organization is run by a 15 member board and one staff member. In 2004 Mrs. Eye received an award for “Unsung Heroes Recognition of North County Community Council” of Juvenile Welfare Board as well as, a National award “Points of Light” for February 2007.
